The Town of Malabar got its 1st official Post Office and name on December 24, 1883 when R.A. Ward was named Postmaster by President, Chester A. Arthur. Two times a week, the boat that travelled down the intracoastal waterway from Jacksonville, would deliver the mail to the palmetto shack post office along the river bank at Malabar. The mail was dumped on the counter for the population of 25 to shuffle through. With the coming of the railroad, in 1893, the mail boat was no longer needed.

Storm Water and Roads

Tropical storm Gordon certainly pointed out the necessity of having a good drainage system. It showed that development of property interrupts the natural flow of water, and places which were not flooded before became impassable. Standing water is not only a nuisance but also a health hazard. Our Town Engineer, Lisa Lombardi, has just completed phase 1 of our storm water management plan. Phase 2 has just begun. If we have enough money and are fortunate enough to obtain some grant money, we will be able to complete this program in 1995.

Because 90 percent of the roads in Malabar are constructed of dirt and sand, repairing and maintaining these roads are top priorities. The Public Works Department grades these roads almost on a daily basis. Some roads are travelled more than others and consequently need more attention. The Town purchased a large amount of marl recently which it will use to start crowning roads. This program will start just as soon as time allows.

MALABAR FIRE DEPARTMENT

The Malabar Fire Department responded to 322 calls in the year 1994. The department, at present, consists of 44 fire-fighters/rescue personnel, 2 fire police, 8 active dispatch/associate members and several applications. Of the 44 active firefighters, 24 are State of Florida certified volunteers, 7 are fully certified firefighters, 8 are EMTs (Emergency Medical Technicians), and 6 are First Responders.



These volunteers are very dedicated and spend many hours away from their families while responding to calls, training, manning the station, and working on the building or equipment. The pagers they carry show no mercy as to the hour they may go off and a volunteer must respond to the station to be sent to a fire, vehicle accident or rescue call.

In 1994 we were inspected by ISO (Insurance Services Office) to set a new insurance rating. The rating for areas in the Town with hydrants changed from 9 to 5 effective November 1st. In some instances, this may result in a cost savings to residents. We are working on having strategically located ponds accepted as water sources to bring the rating down in the remainder of the Town.

By Town Ordinance, yard trash is not be permitted to be burned. Harris Sanitation makes a pick up of yard trash every Thursday. We do however, issue burning permits for first time land clearing.

We are always in search of new members, men and women. No special skills or previous experience is required. If you are interested in learning more about the Malabar Fire Department, or are interested in joining, stop by the station for an application. The department meets every Thursday night for training or business meetings, but the station is manned the majority of the time for calls. We welcome you to stop by and visit or for a tour anytime.



Committees

Country Cove Water

Construction will begin soon on the water line to serve Country Cove residents. The construction, slated to take approximately 60 days, is a result of the developer's agreement between Country Cove and the Town of Malabar. The water line will be an extension of the current water system.

Trash Pickup

Residents are reminded that Harris Sanitation is the trash collector for our Town. In order for them to pick up trash, you must be a current subscriber. It is a violation of law to put trash on the road right-of-way without being a customer, and the Code Enforcement Officer will be enforcing this provision.

Malabar Plans a Park

A State Grant has been approved to give the Town a park near the Fire Department on Malabar Road. The first phase will include exercise areas, a walking (jogging) trail around the lake, rest rooms and parking area. This park will work in conjunction with the County park which adjoins the Town property on the east side to Marie Street. The first phase will be finished in 1995, and then an application for more funding will be made for phase 2 which will include a baseball field, tennis and basketball courts and a soccer field. 
US #1 Corridor Zoning

After the public meetings and Council approval, the US #1 Residential Limited Commercial zoning change has been submitted to the Florida Department of Community Affairs for final approval. It is expected they will render a decision by mid-March. This change was in response to a large majority of residents requesting a change from General Commercial to Residential.
