

**RESOLUTION 19-2008**

A RESOLUTION OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, ALLOCATING MONIES TO THE PROPER ACCOUNT NUMBERS FOR PRINCIPAL AND INTEREST FOR THE LEASED VEHICLES IN THE STREETS AND ROADS DEPARTMENT AND THE FIRE DEPARTMENT; PROVIDING FOR COMPLIANCE WITH THE GOVERNMENTAL UNIFORM ACCOUNTING SYSTEM SET FORTH BY THE DEPARTMENT OF BANKING AND FINANCE OF THE STATE OF FLORIDA BY MAKING THIS CORRECTION; PROVIDING FOR REPEAL OF RESOLUTIONS OR PARTS OF RESOLUTIONS IN CONFLICT HEREWITH; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the Town of Malabar 07/08 Budget incorrectly set up and allocated funds in a *Operating Transfer Out* 9100 line item in both the Streets and Roads and Fire Department accounts; and

**NOW, THEREFORE BE IT RESOLVED BY THE TOWN OF MALABAR OF BREVARD COUNTY, FLORIDA that;**

**SECTION 1.**

Move the line items identified as principal and interest expenses for the ditch mower and dump truck, from 541.9100 to 541.7100 and 7200 series..

**SECTION 2.**

Move the line items identified as principal and interest expenses for the 2004 Mini-pumper and the 2007 Wildland Brush Truck from 522.9100 to 522.7100 and 7200 series.

**SECTION 3.**

All resolutions or parts of resolutions in conflict herewith are hereby repealed.

**SECTION 3. Effective Date.**

This Resolution shall take effect immediately upon passage.
